CONDITIONS AND INDEMNITY

- A. The Organisers (including designated servants and agents) reserve the right to alter or add to these Rules and Regulations as may be necessary for compliance with any laws or with any directions given by the Owners of the Exhibition site, and generally for the efficient running of the Event. The "Exhibitor" shall mean the organisation/group exhibiting, and includes all members, employees and/or agents of the exhibitor and the term "Exhibition" shall mean the 2012 VICTORIAN 4WD SHOW.
- B. **240 volt (quiet) generators** are **only** permitted to be used by exhibitors in NON SEC powered sites, any noisy machinery or audio equipment that may cause annoyance to other Exhibitors or public is **not** permitted, safety precautions must be followed at all times whilst using and / or refuelling generators (A fire extinguisher must be available in case of fire). **All electrical leads must be tagged.**
- C. The Exhibitor undertakes to have their display and all products in complete readiness for 9am opening time on the day of the Exhibition.
- D. No exhibitor shall be permitted to occupy their site unless all monies have been paid.
- E. **PUBLIC LIABILITY INSURANCE** All exhibitors must be adequately covered for Public Liability insurance. This refers to damage or injury caused to third parties/visitors on or in the vicinity of your exhibition stand. In most cases this can be achieved by extending your existing policy through your Insurance Broker or Insurance Company in the form of a "Certificate of Currency". A copy of your Certificate of Currency **MUST** be sent to the Victorian 4WD Show office with your application. Failure to provide proof of Cover (prior to show day) may result in the exhibitor not being able to occupy a site, and forfeiting any rights to a refund of Site Fees.
- F. In the event of the Exhibition having to be cancelled or postponed for whatever reason outside the control of the Organisers, the Organisers may, at their discretion, refund part of the cost of space already paid for by the Exhibitor, but are not required to do so. In such a case the Organisers shall not be liable in any way whatsoever for any expenditure and/or liability or loss including consequential loss incurred by the Exhibitor.
- G. I agree that neither the Members of the Land Rover Owners' Club of Victoria Inc, nor their respective officials, servants, representatives or agents (the Organisers) nor the Owners of the Property shall be liable for any rights of claim for personal injury or property damage or loss of any kind whatsoever and howsoever arising in the course of or in connection with the Exhibition. I further agree to indemnify and keep indemnified and hold harmless the Organisers and the Owners of the Property from and against all claims, demands, actions, suits, expenses, fines, penalties and proceedings which may be brought against or levied upon the Organisers and the Owners of the Property.
- H. The Organisers reserve the right to alter site locations as and when the occasion arises. Whilst every endeavour will be made to meet your site preferences, providing payment has been made with this Registration Form, site layout is absolutely at the discretion of the Organisers. Site layout and allocation of sites may be changed by the Organisers at any time prior to the commencement of the Exhibition, this may be done even if a particular site number, numbers or location has been allocated and/or advised to the exhibitor.
- I. Any exhibitor withdrawing from the Exhibition or failing to occupy their site on the day of the Exhibition shall remain liable for the payment of site costs and shall forfeit any payments made.
- J. **NO DOGS** are permitted on site on any day of the Event, including prior, during, and after the Event. Authorised Guide dogs or similar are permitted.
- K. Sites shall only be occupied by the Applicant who is shown on this Form. Sub-letting or sharing sites with other organisations is not permitted, except with the prior written approval of the Organisers.

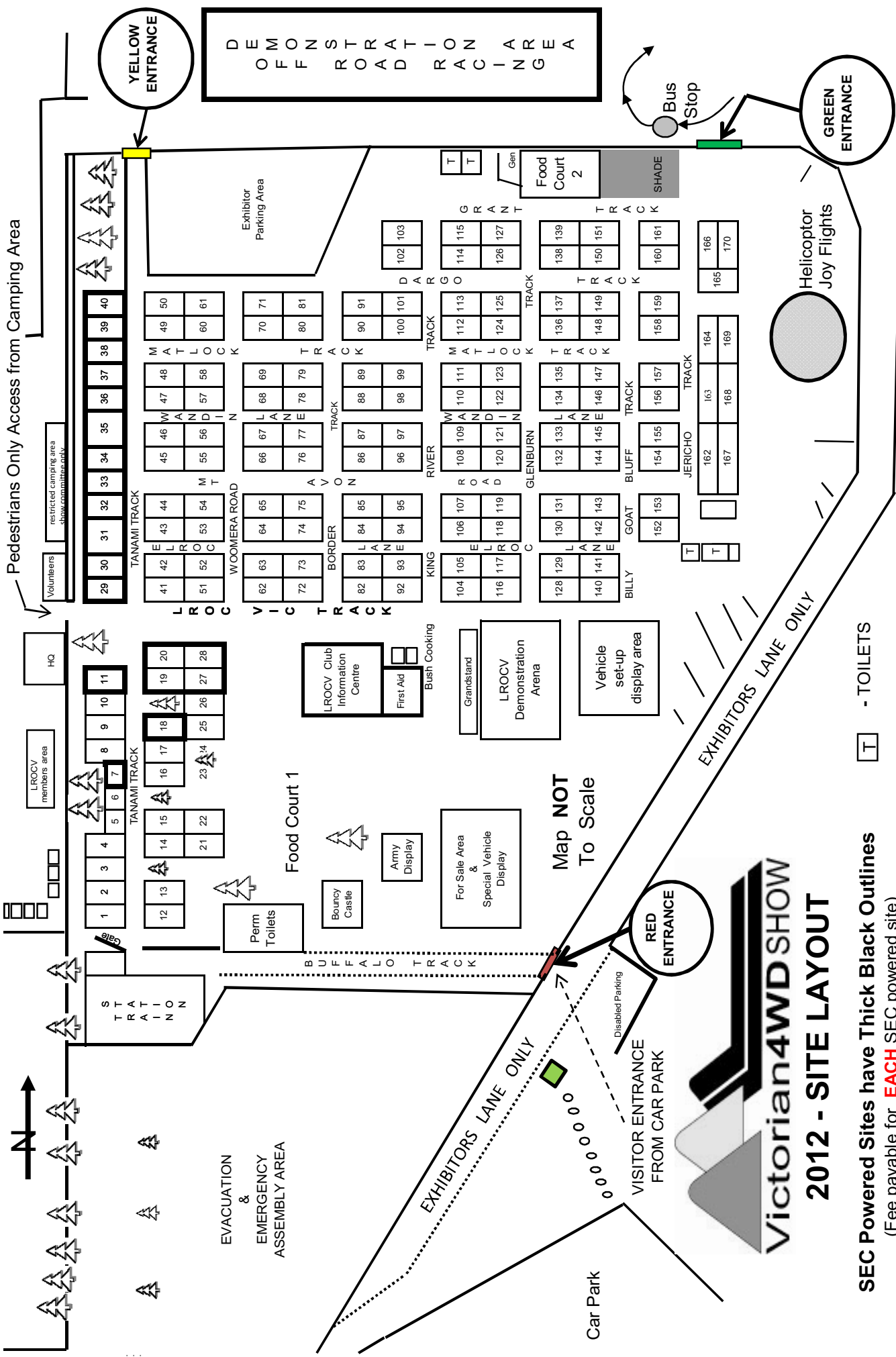
